

## EKF FEES AND CONDITIONS FROM 1 -1 -2026

### 1. ANNUAL MEMBERSHIP FEE ..... 900 €

The deadline for membership fee payment is the day of registration in the European Cadet & Junior Championships. If the payment is made after the deadline, but in the same year, a surcharge of **200 €** will be applied. If the payment is made the year after, a surcharge of **400 €** will be applied. In any case the annual and/or outstanding membership fees must be paid prior to registration of participants at European Championships events.

### 2. REFEREES

#### a) Course registration fees and conditions

**2.a** Indistinctly Kata or Kumite ..... **270 €**

**2.b** Both Kata and Kumite ..... **370 €**

For late registration cases, acceptance will be subject to places being available and a surcharge of **150 €** for each single late registration (kata or kumite) and of **200 €** for each double late registration (kata and kumite) will be applied. If the number of registered applicants exceeds the capacity of the course, the EKF will deal with the relevant National Federations to reduce this number within 1 week.

#### b) License renewal fee PLR

(indistinctly Kata and Kumite every four (4) years) ..... **200 €**

A surcharge fee of **250 €** will be applied in the case of a late payment.

#### c) Registration fees

The registration of qualified referees must be done online by the NFs for officiating in European Championships and will be free of charge when done within the established deadlines For late registration a surcharge of **150 €** will be applied.

#### c) Fine for no-show

Those Referees that register to attend a Referee Course or to officiate an EKF event and do not attend without having sent a legitimate excuse in writing in advance, before the event starts, will have to pay a fine of **200€**.

## 5. REGISTRATION FEES AT EUROPEAN CHAMPIONSHIPS

- Male Kumite team..... **160 €**
- Female Kumite team..... **110 €**
- Male Kata team ..... **110 €**
- Female Kata team..... **110 €**
- Each individual entry..... **80 €**

For late registration (after closure of online registration) a surcharge of **50 €** will be applied for each individual entry and of **80 €** for each team. The same surcharge will have to be paid for entry changes even if they were registered on time, including delegation members other than competitors.
